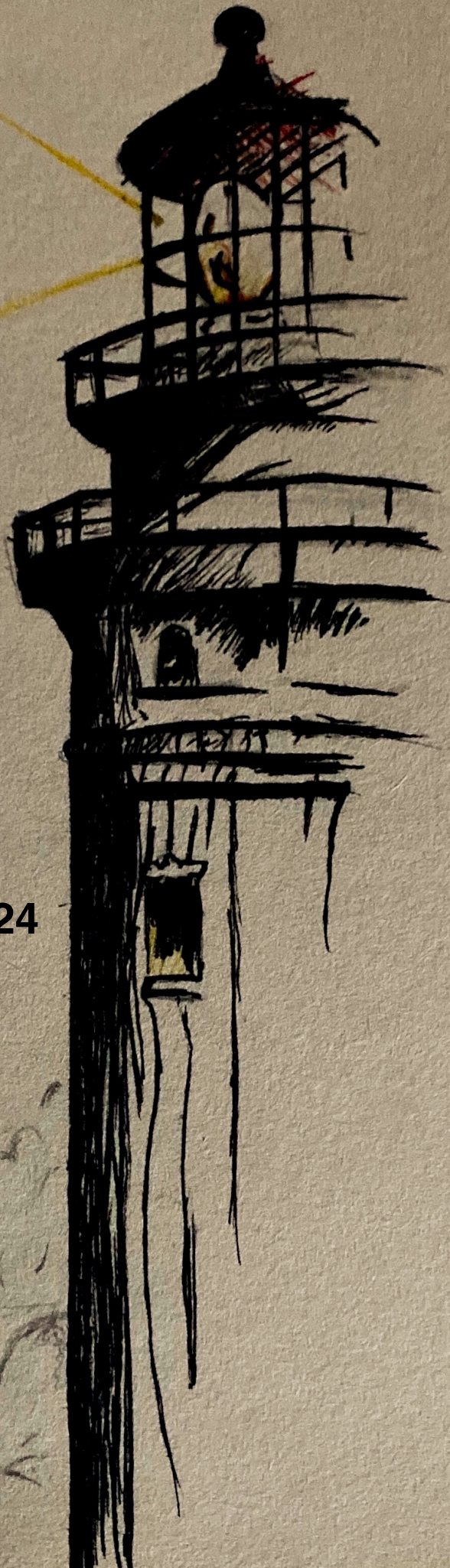

<b>Workshop Description:</b> Early career trajectories face increasing inquiry in management studies due to heightened precarity and external shocks to the business school. Existing literature often lacks problematization of what constitutes early careerism and qualitative insights into the unique challenges of early career academics. This symposium aims to explore narratives from within and beyond those starting academic careers in business schools. We are holding space to share stories of identity work, including pursuing academia alongside parenthood, fulltime professional careers, work practice, and conditions of oppression and marginalization. Presenters share first-voice perspectives in hopes of addressing these systemic issues faced by those starting careers in management education. Attendees will surface challenges and solutions to starting academia differently.

<b>Workshop Description:</b> The place and role of business education has long been the subject of much debate. Following the numerous external shocks to our environment - global pandemic, civil unrest, and political instability – issues involving ‘doing’ management learning have exposed questions about the sustainability of business education as currently practiced. While a small yet blossoming area in historical organization studies has begun to etch out a Canadian history of management learning and education, the potential of an Atlantic Canadian context remains unexplored. Challenges in, and opportunities for, management education in Atlantic Canada might be different from the rest of the country. Our symposium brings together these issues in dialogue with those curious about the future in the region.

**Title:** Truth and silence: why removing NDAs is important for universities and businesses



**Description:** The abuse of non-disclosure agreements or NDAs has become ubiquitous. They now appear in 95% of civil settlement agreements, and are used extensively by universities for terminations, investigations, and in sexual violence complaint outcomes. [Can't Buy My Silence](http://cantbuymysilence.com) (co-founded by Julie Macfarlane with Zelda Perkins, former assistant to Harvey Weinstein) is campaigning for legislative restrictions and also working closely with universities to make a voluntary Pledge (the University Pledge) to stop using NDAs. Legislation has already followed for universities in the UK and in Ontario. What does this mean for your university and your field of work? How do private and public employers use NDAs? What is the impact of NDAs and why is it important to rein them in?

**About Dr. Julie Macfarlane:** Julie is Emerita Distinguished University Professor of Law and a Member of the Order of Canada for her advocacy on access to justice and on behalf of survivors of sexual violence. Julie is Co-Founder with Zelda Perkins of [Can't Buy My Silence](http://cantbuymysilence.com), campaigning to make the misuse of non-disclosure agreements illegal.

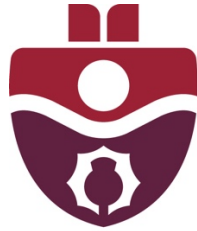
